

# CALL FOR APPLICATION TO PARTICIPATE IN THE NATIONAL QUALITY AWARDS COMPETITION SEASON 6 - 2025

The Ministry of industry and Trade through Tanzania Bureau of Standards in collaboration with Zanzibar Bureau of Standards and Private Sector, is calling for Institutions, Companies and individuals to participate in the National Quality Awards Competition Season Six (6) for the year 2025.

The awards aim to recognize and appreciate organization and individuals who are contributing to quality advancement in all sectors of the nation, by having measurement and quality systems, procedures and processes that are in line with local, regional and international practices and who use quality advancement to support National and regional economic development and growth.

### **CATEGORIES:**

### 1. CATEGORY 1: BEST COMPANY OF THE YEAR

Two awards, SME AND LE: awarded to a <u>company or organization</u> that has pro-actively and effectively implemented quality principles.

### 2. CATEGORY 2: BEST PRODUCT OF THE YEAR

Two awards, SME and LE: awarded to a product that best reflects a commitment to quality.

## 3. CATEGORY 3: BEST SERVICE PROVIDER OF THE YEAR (PRIVATE COMPANY)

Two awards, SME and LE—awarded to a <u>locally-delivered service</u> that best reflects commitment to local production and quality. This category is open from all sectors from private services.

# 4. CATEGORY 4: BEST SERVICE PROVIDER OF THE YEAR (PUBLIC INSTITUTION)

One award for Public Institution (Government) which has it service delivery system aligned to local, regional or international standards.

## 5. CATEGORY 5: BEST EXPORTER OF THE YEAR (Agro Processing)

Two awards, SME and LE - awarded to a company or organization dealing with agricultural products that has made significant progress incommencing or expanding to new or wider markets by introducing quality in their company.

### 6. CATEGORY 6: BEST EXPORTER OF THE YEAR (General products)

Two awards, SME and LE - awarded to a company or organization dealing with other product that has made significant progress in commencing or expanding to new or wider markets by introducing quality in their company

# 7. CATEGORY 7: INDIVIDUAL AWARD TO A PERSON WHO CONTRIBUTED TO SQAM

This award is given to an individual that has made significant input into National Standards, Quality Assurance, Accreditation and metrology efforts that contributed to the improvement of National Quality infrastructures.

# TIPS ON HOW TO PREPARE YOUR NATIONAL QUALITY AWARDS ENTRIES

### Some tips on how to prepare your entry:

Winning in the National Quality Awards can mean National recognition, media exposure and enormous boost of pride for your entire organization. So, it's worth investing some time and effort in an entry that stands a good chance of winning. Here are valuable hints and tips to prepare your awards entry.

# a) Link your achievements to the category criteria

Each category has specific questions and requirements. Make sure your entry is structured to respond to these.

#### b) Use visuals liberally in your entry

The judges are busy and pressed for time. They want to do justice to your entry, but they don't have all day. They're looking for winners, and don't have time to digest irrelevant information in your submission. Helpthem by using visuals in your entry. These could include photographs of activities, charts of your strategy or pictures of products carrying the logo.

#### c) Emphasize the Impact of your activities

Everything your organization does has a wider community impact. Show how your employment affects people. Show how you create opportunities through your supply chair

#### d) Benefits associated with awards

Participation in regional and international quality awards including SADC Quality Awards and EAC Quality Awards.

Winners will be advertised through TBS website, TPSF platforms ZBS website and all social media of TBS and ZBS.

TERMS AND CONDITIONS OF ENTRY

1. The closing date for entries is 30<sup>th</sup> July, 2025 at 23:59 hrs.

2. Entries submitted after this deadline will not be accepted.

3. Companiess/ organizations may enter as many categories as they wish.

4. Only entries sent to the addresses stipulated in this entry form will be accepted for

consideration.

5. All entries become and remain the property of the national competition organizers in the case of

the member country level competition; and the National Quality Awards Secretariat in the

case of entries forwarded to the regional level competition, and will not be returned to the

entrant.

6. Entrants should not disclose any confidential or price-sensitive information, as the confidentiality

of such information cannot be guaranteed.

7. Entry is open only to companies registered in Tanzania. The decision of the adjudicating

panel is final. No correspondence will be entered into after the selection of the winners.

National Quality Awards Secretariat via it's appointed judges reserves the right to determine

the winners at its sole discretion, and is not obliged to divulge entrants 'scores or any other

judging information.

8. The granting of an award to an entrant is subject to the company/organization making

available a senior representative to attend the awards ceremony which will be held on

14<sup>th</sup> November, 2025 during World Quality Day Celebrations.

9. National Quality Awards Committee reserves the rights to withdraw an award from an

entrant in the case of non-attendance.
