- a) Microbiological analysis of bottled drinking water, natural mineral water and potable water by membrane filtration technique;
- b) Microbiological analysis of cosmetics products by pour, spread and streak techniques;
- c) Microbial environmental monitoring in industries and hotels by air settlement and swabbing;
- d) Physicochemical analysis of bottled, mineral and potable water;
- e) Physicochemical analysis of food and beverage products;
