THE STANDARDS (APPOINTMENT OF INSPECTORS) NOTICE, 2021

- WHEREAS, pursuant to section 23(1) of the Standards Act, Cap. 130, the Minister, upon request of the Board, is empowered to appoint any public officer or officer of the Bureau as an inspector for the purposes of the Act;
- WHEREAS, the Bureau in order to effectively carry out its functions under the Act intends to cooperate with the local government authorities by appoint employees of the local government authorities pursuant to sections 4(2)(b) and 23 of the Standards Act, Cap. 130, section 113(2) of the Local Government (District Authorities) Act, Cap. 287 and section 66(3) of the Local Government (Urban Authorities) Act, Cap. 288; and
- NOW THEREFORE, I, Kitila A. Mkumbo (MP), the Minister for Industries and Trade, in the exercise of the powers conferred upon me by section 23(1) of the Standards Act, Cap. 130 and in furtherance of the execution of powers and functions of the Bureau, by this Notice, do hereby appoint inspectors as follows:
- Citation 1. This Notice may be cited as the Standards (Appointment of Inspectors) Notice, 2021.
- Interpretation 2. In this Notice, unless the context requires otherwise-

Cap. 130 "Act" means the Standards Act;

"Director"-

(a) in relation to any District Council, means the District Executive Director appointed for that District Council under the Public Service Act; and

(b) in relation to a Town, Municipality and City Councils, means the Directors appointed under the Public Service Act; and

"Director General" means the Director General of the Bureau appointed under section 7 of the Act.

Appointment of inspectors 3. The employees of the Local Government Authorities holding, acting in, or lawfully performing the functions of the office as designated in the Schedule to this Notice are hereby appointed to be inspectors for the purposes of exercising powers conferred upon them under section 24 of the Act within their respective areas of employment.

Appointment letter 4. The inspectors appointed under paragraph 3 shall be issued with a certificate of appointment in accordance with section 23(2) of the Act and shall comply with the provisions of the Act and regulations made thereunder.
