

TITLE AND SCOPE FOR TOURISM AND RELATED SERVICES STANDARDS

1. TBS/GDC8 (1974) DTZS Adventure tourism -Vocabulary (ISO 3163:2022).

Scope: This document establishes the terms commonly used in various types of adventure tourism activities, including terms related to safety and services.

2. TBS/GDC8 (1472) DTZS Tourism and related services — sustainable tourism — Principle, Vocabulary and model (ISO 23405:2022).

Scope: This document specifies the fundamental concepts and principles of, and a model for, sustainable tourism. This document is applicable to private and public organizations and destinations, regardless of their size and location, plus other interested parties engaged in sustainable tourism development.

3. TBS/GDC8 (1473) DTZS Exhibition, shows fairs and conventions-Part1: Vocabulary (ISO 25639-1:2008).

Scope: This part of ISO 25639 specifies terms and definitions that are commonly used in the exhibition industry. They are grouped into the following four categories:

- individual and entity, which lists and classifies the various types of people involved in the exhibition industry,
- type of event, which defines the different types of exhibitions and their related meetings,
- physical item, which describes the various component sizes of the exhibition, the types of facility and print material, and
- miscellaneous.

4. TBS/GDC8 (1862) DTZS Exhibitions, shows, fairs and conventions — Part 2: Measurement procedures for statistical purposes (ISO 25639-2:2008)

Scope: This part of ISO 25639 establishes standard measurement procedures applicable to terms commonly used in the exhibition industry, as defined in ISO 25639-1.

This part of ISO 25639 is intended for integral use with ISO 25639-1.

5. TBS/GDC8 (1871) DTZS Tourism and related services - Medical tourism -Service requirements (ISO 22525:2020).

Scope: This document establishes the requirements and recommendations for facilitators and healthcare providers in medical tourism.

This document intends to ensure quality service provision for tourists in order to meet the expectations of tourists travelling for medical reasons as a primary motivation.

This document does not apply to thalassotherapy centres, medical spas or wellness spas.

6. TBS/GDC8 (1862) DTZS Tourism and related services -Wellness spa -Service requirements. (ISO 17679:2016).

Scope: This document establishes the service requirements of a wellness spa, the main supporting processes and the quality of service to be provided to the client.

This document can be used by all types and sizes of wellness spas even if it is part of another activity (e.g. accommodation facilities, fitness centres and hospitals).

This document does not include any accommodation or food and beverage requirements.

This document does not apply to medical spas and thalassotherapy centres.

This document does not cover decisions that are related to medical professions, medical training or any religious aspects.
