(NOTICE OF DECLARATION OF EAST AFRICAN STANDARDS), JUNE 2025.

IN EXERCISE of the powers conferred on the Council by section 14(1), (2), and (5) of the East African Community Standardization, Quality Assurance, Metrology and Testing Act, 2006, the titles and scopes of the list of standards below is declared, amended and withdrawn.

A1: LIST OF THE TITLES AND SCOPES OF THE EAS FOR DECLARATION

A) EASC/TC 003, Fish and Fish Products.

1) EAS 871: 2025, Fish sausages — Specification (2nd edition)

This East African Standard specifies requirements, sampling, and test methods for fish sausages intended for human consumption.

This standard applies to fresh fish sausages, cooked fish sausages, smoked fish sausages, dried fish sausages, and fermented fish sausages.

This second edition cancels and replaces the first edition (EAS 871: 2017), which has been technically revised.

2) EAS 895:2025, Fish protein concentrate — Specification (2nd edition).

This East African Standard specifies requirements, sampling, and test methods for fish protein concentrate intended for human consumption.

This second edition cancels and replaces the first edition (EAS 895: 2017), which has been technically revised.

3) EAS 896: 2025, Fried fish — Specification (2nd edition).

This East African Standard specifies requirements, sampling, and test methods for whole or portions of fried fish intended for human consumption.

This second edition cancels and replaces the first edition (EAS 896: 2017), which has been technically revised.

4) EAS 897: 2025, Frozen lobster tails — Specification (2nd edition).

This East African Standard specifies requirements, sampling and test methods for frozen lobster tails of all the species of the genera *Panulirus*, *Homarus* and *Peurulus* intended for human consumption.

This second edition cancels and replaces the first edition (EAS 897: 2017), which has been technically revised.

5) EAS 898:2025, Processing and handling of smoked fish, smoke-flavored fish, smoked dried fish and smoked fish products — Code of practice (2nd edition).

This East African Standard provides guidelines for processing, handling, and storing of smoked fish, smokeflavoured fish, smoke-dried fish, and smoked fish products intended for human consumption.

This second edition cancels and replaces the first edition (EAS 898: 2017), which has been technically revised.

- 6) **EAS 1200: 2025, Canned finfish — Specification (1st edition).**
This East African Standard specifies requirements, sampling and test methods for canned finfish packed in brine, oil, tomato sauce or other suitable packing media intended for human consumption.
- This standard does not apply to specialty products where the canned finfish constitutes less than 50 % m/m, of the net contents of the can.**
- 7) **EAS 1201:2025, Fish flour — specification (1st edition).**
This East African Standard specifies requirements, sampling, and test methods for fish flour, obtained from all types of fish intended for human consumption.
- 8) **EAS 1202:2025, Handling, processing and distribution of retailed fish and fish products — Code of practice (1st edition).**
This East African Standard provides guidelines for handling, processing and distribution of retailed fish and fish products intended for human consumption.
- 9) **EAS 1203: 2025, Fresh/frozen fish roe — Specification (1st edition).**
This East African Standard specifies requirements and methods of sampling and test for fresh/frozen fish roe intended for human consumption.
- 10) **EAS 1204:2025, Dried fish maws — Specification (1st edition).**
This East African Standard specifies requirements, sampling, and test methods for dried fish maws intended for human consumption.
- B) EASC/TC 007, Alcoholic beverages.**
- 11) **EAS 149:2025, Carbon dioxide for beverage industry — Specification (2nd edition).**
1.1 This East African Standard specifies requirements, sampling and test methods for carbon dioxide used in the beverage industry.
1.2 This standard does not apply to the following:
a) carbon dioxide used for fire extinguishers, refrigeration, inflation rafts, welding applications and other general commercial purposes; and
b) Carbon dioxide intended for medical use.
- This second edition cancels and replaces the first edition (EAS 149: 2000), which has been technically revised.*
- C) EASC/TC 012, Seed and propagation materials.**
- 12) **EAS 821: 2025, Maize seed — Requirements for certification (2nd edition).**
This East African Standard specifies the certification requirements for the production of pre-basic, basic and certified seed of maize (*Zea mays* L.). It includes requirements for eligible varieties, field standards, field inspections, seed sampling, laboratory standards, certificates, packaging, labelling, and post-control tests.
- This second edition cancels and replaces the first edition (EAS 821: 2015), which has been technically revised.*
- 13) **EAS 822: 2025, Sorghum seed — Requirements for certification (2nd edition).**
This East African Standard specifies the certification requirements for the production of pre-basic, basic, and certified seed of sorghum (*Sorghum bicolor* (L.) Moench). It includes requirements for eligible varieties, field standards, field inspections, seed sampling, laboratory standards, certificates, packaging, labelling, and post-control tests.
- This second edition cancels and replaces the first edition (EAS 822: 2015), which has been technically revised.*
- 14) **EAS 823: 2025, Sunflower seed — Requirements for certification (2nd edition).**
This East African Standard specifies the certification requirements for the production of pre-basic, basic and certified seed of sunflower (*Helianthus annuus* L.). It includes requirements for eligible varieties, field standards, field inspections, seed sampling, laboratory standards, certificates, packaging, labelling, and post-control tests.
- This second edition cancels and replaces the first edition (EAS 822: 2015), which has been technically revised.*

- 15) **EAS 824: 2025, soybean seed — Requirements for certification (2nd edition).**
This East African Standard specifies the certification requirements for the production of pre-basic, basic and certified seed of soybean (*Glycine max* (L.) Merrill). It includes requirements for eligible varieties, field standards, field inspections, seed sampling, laboratory standards, certificates, packaging, labelling, and post-control tests.
This second edition cancels and replaces the first edition (EAS 824: 2015), which has been technically revised.
- 16) **EAS 825: 2025, Groundnut seed — Requirements for certification (2nd edition).**
This East African Standard specifies the certification requirements for the production of pre-basic, basic and certified seed of groundnut (*Arachis hypogaea* L.). It includes requirements for eligible varieties, field standards, field inspections, seed sampling, laboratory standards, certificates, packaging, labelling, and post-control tests.
This second edition cancels and replaces the first edition (EAS 825: 2015), which has been technically revised.
- D) **EASC/TC 013, Tobacco and tobacco products.**
- 17) **EAS 1194: 2025, Cigars — Specification (1st edition).**
This East African Standard specifies requirements, sampling and test methods for cigars.
- 18) **EAS 1195: 2025, Fin-cut smoking tobacco (roll your own) — specification (1st edition).**
This East African Standard specifies requirements, sampling and test methods for fine-cut smoking tobacco such as Roll-Your-Own (RYO)/Make-Your-Own (MYO).
This standard does not apply to unprocessed tobacco.
- 19) **EAS 1196: 2025, Tobacco and tobacco products — Vocabulary (1st edition).**
This East African Standard specifies terms and definitions used in the tobacco industry.
- 20) **EAS 1197: 2025, Tobacco and tobacco products — Requirements for packaging and labelling (1st edition).**
This East African Standard specifies general requirements for packaging and labelling of tobacco and tobacco products.
- 21) **EAS 1198: 2025, Nicotine pouches — Specification (1st edition).**
This East African Standard specifies requirements, sampling and test methods for nicotine pouches intended for oral use.
This standard does not apply to:
a) pre-portioned, tobacco-free oral nicotine pouches in which the nicotine is not of natural origin;
b) smokeless tobacco products, such as moist snuff, tobacco oral pouches, snus, nasal snuff, chewing tobacco or any other tobacco-containing smokeless tobacco products;
c) nicotine-containing, tobacco-free oral products that are licensed medicinal nicotine products, such as Nicotine Replacement Therapies (NRT);
d) inhaled-nicotine products, such as cigarettes, other combusted tobacco products, tobacco-heating products or e-cigarettes; and
e) method for assessing the health risks or potential reduced health risks of tobacco-free oral nicotine pouches.
- E) **EASC/TC 014, Cereals and Pulses.**
- 22) **EAS 2: 2025, Maize grains — Specification (5th edition).**
This East African Standard specifies requirements, sampling and test methods for maize grain of varieties grown from common maize grain, *Zea mays indentata* L. and/or *Zea mays indurata* L. *Zea mays everta* or their hybrids intended for human consumption.
This fifth edition cancels and replaces the fourth edition (EAS 2: 2017), which has been technically revised.
- 23) **EAS 754: 2025, Chick peas — Specification (2nd edition).**
This East African Standard specifies requirements, sampling and test methods for dry chickpeas of the varieties (cultivars) grown from *Cicer arietinum* Linn. intended for human consumption.
This second edition cancels and replaces the first edition (EAS 754: 2013), which has been technically revised.

- 24) **EAS 762: 2025, Dry Soybeans — Specification (3rd edition).**
This East African Standard specifies requirements, sampling and test methods for dry soybeans of varieties (cultivars) grown from *Glycine max* (L.) Merr: intended for human consumption.
This third edition cancels and replaces the second edition (EAS 900: 2017), which has been technically revised.
- 25) **EAS 765: 2025, Brown rice — Specification (2nd edition).**
This East African Standard specifies requirements, sampling and test methods for brown rice of the varieties grown from *Oryza spp.*, intended for human consumption
This standard also covers the parboiled brown rice.
This second edition cancels and replaces the first edition (EAS 765: 2013), which has been technically revised.
- 26) **EAS 900: 2025, Cereals, Pulses and their products — Sampling (3rd edition).**
This East African Standard specifies requirements for the dynamic or static sampling, by manual, electronic or mechanical means, for assessment of compliance to East African standards for cereals, pulses and their products.
It is not applicable to seed grain.
This third edition cancels and replaces the second edition (EAS 900: 2017), which has been technically revised.
- 27) **EAS 901: 2025, Cereals, pulses and their products — Test methods (3rd edition).**
This East African Standard specifies the test methods for cereals, pulses and their products.
This third edition cancels and replaces the second edition (EAS 901: 2017), which has been technically revised.
- F) **EASC/TC 015, Oils and fats.**
- 28) **EAS 14: 2025, Fat spreads and blended spreads — Specification (3rd edition).**
This East African Standard specifies requirements, sampling, and test methods for fat spreads and blended spreads.
This standard does not apply to fat spreads and blended spreads derived exclusively from milk and/or milk products to which only other substances necessary for their manufacture have been added, such as butter and dairy spreads.
This third edition cancels and replaces the second edition (EAS 14: 2018), which has been technically revised.
- 29) **EAS 297: 2025, Edible soya bean oil — Specification (3rd edition).**
This East African Standard specifies requirements, sampling, and test methods for virgin and refined soya bean (soybean) oil derived from seeds of soya beans (*Glycine max* (L.) Merr) intended for human consumption.
This third edition cancels and replaces the second edition (EAS 297: 2013), which has been technically revised.
- 30) **EAS 1222: 2025, Edible canola (rapeseed) oil — Specification (1st edition).**
This East African Standard specifies requirements, sampling, and test methods for virgin and refined canola (rapeseed) oil derived by extraction from seeds of *Brassica napus* L., *Brassica rapa* L., *Brassica juncea* L, and *Brassica tournefortii* Gouan species intended for human consumption.
- 31) **EAS 1223: 2025, Edible macadamia oil — Specification (1st edition).**
This East African Standard specifies requirements, sampling, and test methods for virgin and refined macadamia oil derived from the kernel of the macadamia nuts of varieties grown from *Macadamia integrifolia* and *Macadamia tetraphylla* and their hybrids, intended for human consumption.
- G) **EASC/TC 017, Milk and milk products.**
- 32) **EAS 33: 2025, Yoghurt — Specification (4th edition).**
This East African Standard specifies requirements, sampling, and test methods for yoghurt, alternate culture yoghurt, and acidophilus milk.
This fourth edition cancels and replaces the third edition (EAS 33: 2019), which has been technically revised.
- 33) **EAS 1008: 2025, Fermented (cultured) milk — Specification (2nd edition).**
This East African Standard specifies requirements, sampling, and test methods for fermented (cultured) milk intended for human consumption.
This standard does not apply to products covered in EAS 33.
This second edition cancels and replaces the first edition (EAS 1008: 2021), which has been technically revised.

- 34) **EAS 1191: 2025, Flavoured milk — Specification (1st edition).**
This East African Standard specifies requirements, sampling, and test methods for flavoured and sweetened milk intended for human consumption.
- 35) **EAS 1193:2025, Lactose-free milk — specification (1st edition).**
This East African Standard specifies requirements, sampling, and test methods for lactose-free milk intended for direct human consumption or for further processing.
- H) **EASC/TC 020, Agriculture and Agrochemicals.**
- 36) **EAS 456: 2025, Organic production – Requirements (3rd edition).**
This East African Standard specifies requirements for organic production. It covers plant production, animal husbandry, aquaculture, sustainable fisheries, bee-keeping, the harvesting of wild products, and the processing and labelling of the products therefrom.

This standard does not apply to procedures for verification, such as inspection or certification of products.

This third edition cancels and replaces the second edition (EAS 456: 2019), which has been technically revised.
- I) **EASC/TC 028, Construction of roads, rails, air and water transport infrastructure.**
- 37) **EAS 1206: 2025, Geometrical design of roads — Code of practice (1st edition).**
This East African Standard provides guidelines for geometrical design of roads.
This standard is applicable to all mobility and access roads of Class 1, Class 2, Class 3, Class 4 and Class 5 as explained in 5.1.
- 38) **EAS 1207: 2025, Asphalt paving mix design — Code of practice (1st edition).**
This East African Standard provides guidelines for the design of asphalt paving mixtures to be used for general asphalt pavements.

This standard is applicable to the design of Hot Mix Asphalts (HMA) produced from new (virgin) asphalt materials and reclaimed (recycled) asphalt materials in the design process.

NOTE The guidelines for the mix design given in Clause 6 are based on commonly used asphalt design methods mainly Superpave HMA Mix Design System, Marshall method of asphalt mix design and Hveem method of asphalt mix design.
- J) **EASC/TC 039, Mechanical Engineering and Metallurgy.**
- 39) **EAS 1213: 2025, Air conditioning appliances for household and similar use — Minimum Energy Performance-Requirements (1st edition).**
This East African Standard specifies the minimum energy performance and energy labelling requirements for electrical non-ducted single-split, self-contained air-cooled air conditioners, air-to-air reversible heat pumps, and portable air conditioners, with a rated cooling output of up to 16 kW, placed on the market for any application.

This standard does not apply to:
 - water-cooled air conditioners,
 - water-source heat pumps,
 - multi-split air conditioners,
 - multi-split air-to-air heat pumps,
 - variable refrigerant flow systems, and
 - ducted equipment as well as non-electric energy sources
- 40) **EAS 1214: 2025, Refrigerating appliances for household and similar use — Minimum Energy Performance-Requirements (1st edition).**

This East African Standard specifies the Minimum Energy Performance and energy labelling requirements for a.c. powered single-phase (220-240V, 50Hz) and three-phase (380-415V, 50Hz) vapor compression refrigerating appliances (that is, refrigerators, refrigerator-freezers and freezers) of rated volume from 10 L to 1 500 L for household and similar use.

This standard does not apply to:

- (a) wine storage appliances,
- (b) mobile refrigerating appliances,
- (c) appliances where the primary function is not the storage of foodstuffs through refrigeration, and
- (d) Refrigerating appliances powered by other sources other than electricity

Other refrigerating appliances different from the vapour compression type.

K) EASC TC 065, Paper and paper products.

41) EAS 355 - 1: 2025, Toilet paper — Specification — Part 1: Regular toilet tissue paper (3rd edition).

This East African Standard specifies requirements, sampling, and test methods for regular toilet tissue paper made from virgin, blended, or recycled pulp.

This third edition cancels and replaces the second edition (EAS 355-1: 2017), which has been technically revised.

L) EASC/TC 068, Petroleum and petroleum products.

42) EAS 158: 2025, Automotive gasoline (Premium Motor Spirit) — Specification (4th edition).

This East African Standard specifies requirements, sampling and test methods for automotive gasoline (Premium Motor Spirit), also commonly known as petrol, for use in spark ignition engines.

The standard applies to Premium Motor Spirit (PMS) as manufactured, stored, transported and marketed.

This fourth edition cancels and replaces the third edition (EAS 158: 2019), which has been technically revised.

43) EAS 177:2025, Automotive Gas Oil (Automotive Diesel)-Specification (4th edition).

This East African Standard specifies requirements, sampling and test methods for Automotive Gas Oil (AGO), commonly known as diesel, used to power internal combustion engines.

The standard applies to automotive gas oil (automotive diesel) as manufactured, stored, transported and marketed.

This fourth edition cancels and replaces the third edition (EAS 177: 2019), which has been technically revised.

44) EAS 1105:2025, Liquefied Petroleum Gas (LPG) — Specification (1st edition).

This East African Standard specifies requirements, sampling and test methods for Liquefied Petroleum Gases (LPG) intended for use as domestic, commercial and industrial heating and engine fuels.

This standard covers LPG consisting of commercial propane, commercial butane and commercial propane butane (PB) mixture.

45) EAS 1211: 2025, Illuminating kerosene — Specification (1st edition).

This East African Standard specifies requirements, sampling and test methods of illuminating kerosene suitable for use in domestic, commercial and industrial application.

46) EAS 1212: 2025, Industrial Diesel Oil (IDO) — Specification (1st edition).

This East African Standard specifies requirements, sampling and test methods for Industrial Diesel Oil (IDO), used as a fuel for industrial applications such as heating, power generation and industrial furnaces.

M) EASC/TC 070, Paints, varnishes and related products.

47) EAS 849:2025, Silk (sheen) emulsion paint for interior use — Specification (3rd edition).

This East African Standard specifies requirements, sampling, and test methods for silk (sheen) emulsion paint for interior use.

This third edition cancels and replaces the second edition (EAS 849: 2021), which has been technically revised.

48) EAS 851: 2025, Matt emulsion paint for interior and exterior use — Specification (2nd edition).

This East African Standard specifies requirements, sampling and test methods for matt emulsion paint for interior and exterior use. covered by EAS 290-1.

This second edition cancels and replaces the first edition (EAS 851: 2016), which has been technically revised.

N) EASC/TC 071, Cosmetics and related products.

49) EAS 461-1: 2025, Hair dye — Specification — Part 1: Aryl diamine based formulated powder (3rd edition).

This East African Standard specifies requirements, sampling, and test methods for aryl diamine-based formulated powder hair dyes.

This standard only covers permanent powder hair dyes based on aryl diamines, which act as primary intermediates in dyes.

The standard does not apply to vegetable-based hair dyes, metallic based hair dyes and liquid hair dyes

This third edition cancels and replaces the second edition (EAS 461-1: 2013), which has been technically revised.

50) EAS 461-2: 2025, Hair dye — Specification — Part 2: Aryl di-amine-based liquid oxidation (1st edition).

This East African Standard specifies requirements, sampling and test methods for permanent liquid oxidation hair dyes which are aryl diamine based.

This standard does not apply to powder hair dyes, plant-based hair dyes, hair dye shampoo and temporary metallic based hair dyes.

This standard cancels and replaces (EAS 844: 2017), which has been technically revised and renumbered as EAS 461-2:2025, being part of the family of EAS 461. The EAS 844:2017 is hereby withdrawn.

51) EAS 1205-1: 2025, Skincare special purpose product — Specification — Part 1: anti-aging (1st edition).

This East African Standard specifies requirements, sampling and test methods for anti-aging products.

This standard does not apply to skincare products covered by EAS 786, aromatherapy substances, sun protection products and hair creams, lotions and gels.

52) EAS 1205-2: 2025, Skincare special purpose product — Specification — Part 2: Sunscreen (1st edition).

This East African Standard specifies requirements, sampling and test methods for sunscreen skincare leave-on products. This standard does not apply to skincare products covered by EAS 786, anti-wrinkle products, anti-aging products, aromatherapy substances, and hair creams, lotions and gels.

O) EASC/TC 076, Services.

53) EAS 1183: 2025, Emergency Medical Services — Ground ambulance – Requirements (1st edition).

This East African Standard establishes the requirements which a provider shall comply with when operating/providing ground ambulance services.

This standard specifies categories of ambulances based on increasing order of the level of treatment that can be carried out.

54) EAS 1184:2025, Emergency Medical Services — Water ambulance — Requirements (1st edition).

This East African Standard establishes the requirements for water Ambulance Services. The standard is applicable to ambulances capable of referring at least one person on a stretcher.

55) EAS 1185:2025, Business Development Services — Delivery of Business Development Services — Guidelines for Service Providers (1st edition).

This East African Standard provides guidelines for delivering Business Development Services (BDS).

The guideline can be used by solo practitioners and organisations, working in an urban or rural setting, at a parish, district, or regional level to:

- a) improve their processes for service delivery;
- b) Align interventions to the context of the BDS client, their development life cycle, position in the value chain, and the vertical level at which the MSME is operating.
- c) Enable consistent delivery of BDS.

P) EASC/TC 078, Healthcare and medical devices (3 EAS).

56) EAS 1119-3: 2025, Skin applied mosquito repellents — Specification — Part 3: Wipes (1st edition).

This East African Standard specifies requirements, sampling and test methods for skin applied mosquito repellent

wipes.

- 57) **EAS 1119-4: 2025, Skin applied mosquito repellents — Specification — Part 4: Bathing soap (1st edition).**
This East African Standard specifies requirements, sampling and test methods for skin applied mosquito repellent bathing soap.

- 58) **EAS 1119-5: 2025, Skin applied mosquito repellents — Specification — Part 5: Bracelets, wristbands and patches (1st edition).**
This East African Standard specifies requirements, sampling and test methods for skin applied mosquito repellents, prepared as bracelets, wristbands and patches directly to human skin.

- Q) **EASC/TC 081, Drinking water.**

- 59) **EAS 12: 2025, Potable water— Specification (4th edition).**
This East African Standard specifies requirements, sampling and test methods for potable water intended for direct human consumption, domestic and industrial use.

This fourth edition cancels and replaces the third edition (EAS 12: 2018), which has been technically revised.

- 60) **EAS 153: 2025, Packaged drinking water — Specification (4th edition).**
This East African Standard specifies requirements, sampling and test methods for packaged drinking water for direct human consumption

This fourth edition cancels and replaces the third edition (EAS 153: 2018), which has been technically revised.
